The Regular Board Meeting of the Board of Commissioners for Island Hospital was called to order by Commissioner Iversen at 12:00 pm on June 23rd in Cypress Conference Room. Due to the ongoing COVID 19 Pandemic the Regular Board Meeting was conducted via WebEx.

Program Update:

Soltive Urology Laser Demo: Dr. Kevwitch and Nadia Qutmish, Olympus Medical, provided a demo on the new Island Hospital Soltive Urology Laser. BOARD QUALITY & PATIENT SAFETY REPORT

Medical Staff Meeting Summaries:

Dr. Rieger introduced Dr. Rob Carter. Dr. Carter will assume the role of Chief of Staff on July 1, 2021. Dr. Carter expanded on his personal and professional background. All in attendance welcomed Dr. Carter.

Charles recognized Dr. Rieger for his contributions to the Island Hospital Medical Staff while serving as Chief of Staff from July 2019-June 30, 2021. The Commissioners commended Dr. Rieger for his service while serving as Chief of Staff and for his involvement in the community.

Financial Update:

<u>Financial Statement Review</u>: Julie Norton Stewart reported on the May 2021 financial statements with the Commissioners and highlighted the following as significant items:

- ♦ <u>Balance Sheet</u> The hospital collected \$8.7 million in cash in May and paid out \$7.9 million. This resulted in day's cash on hand of 248.7 (222.5 in operating cash funds) up from April of 245.9. The current ratio increased to 2.15 from 2.14 in April.
- ♦ <u>Net Revenue</u> Net revenue for May 2021 was \$9.2 million with an actual collection rate of 39.4% which is below the budgeted 41.9%. Outpatient gross revenue as a percentage of total revenues decreased to 80% of the total gross revenue. Hospital net revenue was above budget 1% and Primary Care and Specialty Clinics net revenue was below budget by 15.7%. For the month of May the Hospital meet its financial pillar goal of an operating margin of net revenue to meet or exceed 1%, with an actual operating margin of 5.9%.
- ♦ Operating expenses Total operating expenses for 2021 are 8.1% below budget and 14.1% above 2019. Wages, Salaries and benefits were 9.2% below budget. Supplies are 18% below budget. Professional and physician fees are 6.5% below budget. Purchased services are 4.4% above budget. Drug expense is .9% below budget. The total number of FTE's for 2021 is 532 which is under the budget of 594 and 44 less than 2020. The Hospital recorded net operating income for 2021 of \$333,000 versus the budgeted operating income of \$306,000. The excess margin for 2021 is \$2,093,000 or 5% of net revenue versus budgeted excess margin of \$2,194,000 or 4.8% of net revenue.
