Financial Update:

Financial Statement Review: Elise Cutter reported on the October 2020 financial statements with the Commissioners and highlighted the following as significant items:

- ◆ **Balance Sheet** – The hospital collected \$20.8 million in cash in October (which included \$11.2 million in additional Medicare Advance Funding) and paid out \$7.1 million. This resulted in day's cash on hand of 263.7 (231.9 in operating cash funds) up from September of 209.7. The current ratio decreased to 1.70 from 2.05 in September.
- ◆ **Net Revenue** – Net revenue for October 2020 was \$8.6 million with an actual collection rate of 39.6% which is below the budgeted 41.2% due to the higher percentage of outpatient to total revenue. Outpatient gross revenue as a percentage of total revenues increased to 85% of the total gross revenue. Hospital net revenue fell below budget 3.3% and Primary Care and Specialty Clinics net revenue was below budget by 5.6%. For the month of October the Hospital **met** its financial pillar goal of an operating margin of net revenue to meet or exceed 1%, with an actual operating margin of 1%.
- ◆ **Operating expenses** – Total operating expenses for October are 2.6% below budget and 2.5% below the prior year. Wages, Salaries and benefits were 6% below budget and 1% below prior year. Supplies are 7.3% above budget primarily in Lab related to COVID testing supplies and below prior year by 2.4%. Professional and physician fees are 20.2% below budget and 31% below prior year. Purchased services are 12.5% above budget and 7.9% above prior year due to contract labor and other contracted services. Drug expense is 37.6% above budget and 24.1% above prior year related to oncology and flu vaccines. The total number of FTE's for 2020 is 494 which is under the budget of 579 and 38 less than 2019. The Hospital recorded a net operating income for October of \$86,000 versus the budgeted operating income of \$188,000. The excess gain for October is \$461,000 or 5.4% of net revenue versus budgeted excess gain of \$570,000 or 6.4% of net revenue.
