Financial Update:

<u>Financial Statement Review</u>: Elise Cutter reported on the November 2020 financial statements with the Commissioners and highlighted the following as significant items:

<u>Financial Statement Review</u>: Elise Cutter reported on the November 2020 financial statements with the Committee and highlighted the following as significant items:

- ♦ <u>Balance Sheet</u> The hospital collected \$8.1 million in cash in November and paid out \$8.1 million. This resulted in day's cash on hand of 262.5 (235.7 in operating cash funds) down from October of 263.7. The current ratio increased to 1.74 from 1.70 in October.
- ♦ Net Revenue Net revenue for November 2020 was \$8.3 million with an actual collection rate of 40.7% which is below the budgeted 41.6% due to the higher percentage of outpatient to total revenue. Outpatient gross revenue as a percentage of total revenues increased to 83% of the total gross revenue. Hospital net revenue was **above** budget .7% and Primary Care and Specialty Clinics net revenue was below budget by 13.8%. For the month of November the Hospital **met** its financial pillar goal of an operating margin of net revenue to meet or exceed 1%, with an actual operating margin of 1.5%.
- ♦ Operating expenses Total operating expenses for November are 1.8% below budget and 3.7% above the prior year. Wages, Salaries and benefits were 8.5% below budget and .1% above prior year. Supplies are 12.4% above budget primarily in Lab and Surgery and below prior year by 1.2%. Professional and physician fees are 13.3% below budget and .2% above prior year. Purchased services are 5.2% below budget and 4.5% above prior year due to contract labor and other contracted services. Drug expense is 21.6% above budget and 106.5% above prior year related to oncology and flu vaccines. The total number of FTE's for 2020 is 498 which is under the budget of 579 and 35 less than 2019. The Hospital recorded a net operating income for November of \$123,000 versus the budgeted operating income of \$142,000. The excess gain for November is \$518,000 or 6.2% of net revenue versus budgeted excess gain of \$522,000 or 6.2% of net revenue.
- ♦ are 20.2% below budget and 31% below prior year. Purchased services are 12.5% above budget and 7.9% above prior year due to contract labor and other contracted services. Drug expense is 37.6% above budget and 24.1% above prior year related to oncology and flu vaccines. The total number of FTE's for 2020 is 494 which is under the budget of 579 and 38 less than 2019. The Hospital recorded a net operating income for October of \$86,000 versus the budgeted operating income of \$188,000. The excess gain for October is \$461,000 or 5.4% of net revenue versus budgeted excess gain of \$570,000 or 6.4% of net revenue.

IHF: Jeannette Papadakis shared recent grateful patients and donor greetings, provided an update on year to date donations which are over \$2.2 million, provided updates on the Holiday Appeal, 2020 Employee Giving Campaign and Giving Tuesday campaigns, Remarked on the recent Foundation Board Retreat and Strategic Plan and shared details of the ongoing Executive Director Transition Plan with Janie Crane. Jeannette thanked Shirley Vacanti for her leadership as the President for the Island Hospital Foundation Board and welcomed James Tangaro will be serve as Board President in 2021.
